Introduction

Buldes 2006 Ltd. wants to protect the privacy of visitors to our website. Before continuing, please take a few moments to read out the following policy, it will help you to understand how we use and process your personal data. We may change our Privacy and Data Protection Policy at any time without giving you notice, so please check it each time you visit our website.

What personal data do we collect?

We log your Internet Protocol (IP) address in order to receive and send information from and to you over the internet.

When you visit our website, make an enquiry or request more information, you may be asked to provide some personal data such as your name, address, telephone number and e-mail address. In the event you decide to provide personal data, this policy will apply.

Cookies

What is a Cookie

A cookie is a small piece of data or message that is sent from an organisation's web server to your web browser and is then stored on your hard drive. Cookies can't read data off your hard drive or cookie files created by other sites, and do not damage your system.

However, you can reset your browser so as to refuse any cookie or to alert you to when a cookie is being sent. Web browsers allow you to control cookies stored on your hard drive through the web browser settings. How do we use your personal data?

We use your personal data to provide information to you or your organization.

We may also use your personal data to carry out research about our visitors' demographics and interests. We do this to better understand our visitors. This research is compiled and analyzed on an aggregated and anonymous basis.

Who has access to your personal information?

The data shall be processed in accordance with this Privacy and Data Protection Policy and with the Bulgarian laws. The people granted rights of access of your personal information are the members of the Marketing Department.

To whom might we disclose your personal data?

Except as set out above, we will not disclose your personal information unless we are obliged to do so or allowed to do so, by law, or where we need to do so in order to run our business (for instance where we outsource services or other people process data for us).

Length of retaining personal data

All records of personal data, gathered through the website, shall be kept for 26 months.

However, you may request to have your information deleted from our records at any time by sending an email at buldes2006@gmail.com.

Your information will be deleted up to 1 month after the submission of your request.

Subject rights

At any time during the processing of your personal data, you have certain rights.

You can exercise your rights under the General Data Protection Regulation by sending an email to buldes2006@gmail.com or a letter to our address in the contact information below that contains your specific request and which, if possible, is signed by you in person or with a qualified electronic signature. If you are unable to sign your request in one of our preferred ways, we may ask you to provide additional information for your identification. We will respond to your request for free and within 1 month.

You can exercise your right to lodge a complaint to Commission for personal data protection, the supervisory authority, on e-mail address - kzld@cpdp.bg.
